CALL TO ORDER

APPROVAL OF JULY 22, 2013

REPORTS

Treasurer's Report

Trethan distributed and reviewed the Treasurer's Report.

Communication Director's Report

Threlfall reported that there were 681 visits to the CARE website since the last meeting and 540 were unique visitors. There are 188 directory members and 199 email addresses which he continues to collect. Additionally 60% of the visitors use Windows, 22% Mac and 12% I-Phone.

He distributed the list of assignments for the Winter 2013 newsletter. The deadline date is November 11, 2013. He also reviewed the list of board members who have submitted a biography for the newsletter and those who have not submitted one. The sent-out date will be the first week of December.

CARE Fund

Allen reported on the CARE funds for fiscal year July 1, 2012, through June 30, 2013. Luise Laurie, a Chabot retiree, made a generous and substantial contribution to the CARE Fund.

Rheinheimer reported that an email was sent announcing that CARE Grant applications were available. To date no applications have been submitted. A discussion ensued on how to encourage faculty and staff to apply for funds. It was suggested that key groups on the campuses such as the Academic and Classified Senates, Chabot Las Positas Faculty Association and Service Employee International Union be notified. Furthermore she recommended that all board members get the word out. The new deadline is November 15, 2013.

A co-curricular fund will be set up at the Chabot College President's Office for the distribution of CARE Grant proceeds. Checks will be made out to the college instead of the applicant granted CARE funds. This will provide for fiscal control. A similar process will be set up with Las Positas College.
