All Institutions who participate in federal student aid programs are required to compile and publish Clery Act crime statistics, but many program reviews highlight examples where institutions did not appropriately classify specific Clery act crimes according to Clery Act definitions or statistics reported to the Department of Education. Clery Act reporting is also tied to specific Clery Act geography, on-campus buildings and property, public property, and noncampus buildings and property. Understanding what buildings and property the institution owns or controls is a critical first step to Clery compliance because all reporting is tied to this geography. Being able to have the proper tools and materials for the Officers will only enhance their knowledge and understanding of the Clery requirements.

Having a reference guide serves as an easy-to-use reference for classifying Clery Act crimes and offenses.
